Order Accepting Appraisal Roll; and Setting Tax Rate and Levying a Maintenance Tax for the Year 2020

The Board of Directors (“Board”) of Harris County Municipal Utility District No. 179 (“District”) met at the Board’s regular meeting place on November 22, 2020, with a quorum of Directors present.

The following business was transacted:

The order set out below was introduced and considered by the Board. It was then moved, seconded and carried that the following order be adopted:

WHEREAS, the Chief Appraiser of Harris County has prepared and certified to the District’s tax assessor-collector the appraisal roll of the District for the year 2020.

WHEREAS, a majority of the electors voting in an election held for and within the District have heretofore approved and authorized the levy and collection of a tax for maintenance purposes in the District, including funds for planning, maintaining, repairing, and operating all necessary plants, properties, facilities, and improvements of the District and for paying costs of proper services, engineering and legal fees, and organization and administrative expenses of the District; and

WHEREAS, the Board has determined that additional funds are required by the District during the coming year for maintaining, repairing, and operating District plants, facilities and improvements and for paying costs of proper services and administrative expenses;

NOW, THEREFORE, BE IT ORDERED by the Board of Directors as follows:

I.

The Board hereby accepts the appraisal roll of the District as prepared and certified by the Chief Appraiser for the year 2020.

II.

The Board hereby levies and directs that there be assessed upon all taxable property within the District a maintenance tax for the year 2020 at the rate of \$0.2665 per \$100 of assessed valuation. Taxes shall be due and payable when billed and shall be paid on or before January 31, 2021.

III.

All taxes not paid before February 1, 2021, shall become delinquent on that date, and there shall be added to the tax penalty and interest as provided in V.T.C.A., Property Tax Code.

IV.

The tax assessor-collector for the District is hereby authorized and instructed to proceed to collect the aforesaid taxes upon the basis of this order.

V.

The President or Vice President is authorized to execute and the Secretary or Assistant Secretary to attest this order on behalf of the Board and District, and to do any and all things appropriate or necessary to give effect to the intent hereof.
